1. City Landfill / Draper:

a. Monitor / Track / Record

- i. SE Chimney and other locations if discovered
- ii. North and South end cleanouts
- iii. Gas well temperatures
- iv. Daily plant gas flows, 600-700 range
- v. Monitor gas probes 498
- vi. Leachate and Gradient volumes

b. Cover

- i. Continue to apply additional cover, raised wells and improved cover in south
- ii. Posi Shell is operational and planning for additional usage

c. Work Force

i. Additional employee search ongoing

d. Gas Collection System

- 1. SCS tuning well field and addressing O & M
 - a. 2 X last week
 - b. 3 X this week
- 2. Adding pressure and temp gauges
- 3. Receiving bids to remove sediment from the wells
- 4. Planning for next expansion

e. Flare

- i. Ingenco upgrades, substantially complete
 - 1. Next step new blower
- ii. Second Flare is online, if and when needed

f. Odor Remediation

i. Pilot program is being evaluated
