# Summary of Actions Taken Since the Last Call

- SCS Personnel completed regular well and pump maintenance Week of 4/17/23
  - o 588 wellfield readings first time readings for 80, 84, 86, 90
  - o Samples taken at EW-37, 54, 61, 84, 86, 90
  - o Wellhead replacement at EW-48
  - o Pump replacement at EW-49, 53, 59
  - o EW-93, 94, 95, 98, 99, 100 connected to vacuum
- SCS Personnel completed regular well and pump maintenance Week of 4/24/23
  - o 588 Wellfield readings Initial wellhead reading taken at EW-60, 70, 73, 76, 78
  - o Samples taken at EW-37, 84, 86, 90, 100
  - Wellheads and kanaflex replaced at EW-41, 47, 54, 57
  - o EW-52 & 68 regulator and airline replaced
  - o Pump pulled at EW-59, placed well skirt around 59 and replaced pump
  - 4 pumps sent back to Pumpone for repair and rebuild
- Sidewall Odor Mitigation System:
  - o Completed upper collector and soil up to the last 300ft of the northern section
  - Continued shotcrete placement
- Phase 1 LFG System Construction
  - o 18 CPVC wells connected to vacuum
  - o 820-ft of 12-in header installed
  - First shipment of stainless steel pipe delivered 4/27/23
